

Pre-Construction Services Update

Since our last update in June of 2022, there has been a great deal of activity in our Pre-Construction Department, with three projects awarded with a total value of over \$48 Million.

These projects are:

- Rebuild MDP 2 at Pumpwell 2, Bremerton, WA
- Replace Type III Hydrant Fuel System at General Mitchell ANGB, Milwaukee, WI
- HEAF Atrium Conversion at Lawrence Livermore National Laboratory, CA

In addition, we are currently awaiting decisions on several important projects totaling approximately \$170 Million, and we will likely be bidding projects in 2023 with values totaling hundreds of millions of dollars. So, our prospects look good.

Beyond that, our Pre-Construction Services Team remains the same, with Connor Greene serving since June as a Proposal Coordinator reporting to Proposal Manager Al Anderson.

Brenda Abel-Kiser has settled into her new role as Vice President of Pre-Construction, while Charlie Gay has also been thriving as Chief Estimator. SHOP, ENGINEERING & EQUIPMENT UPDATES

The Engineering and Shop team closed out 2022 with some great milestones. The Shop completed a fifth straight year injury free while continuing to grow our leading indicator programs, turning in over 250 Good Catch Reports in 2022. The team also passed our audits with the SSPC, the FAA, and the AISC (for the 24th year!) without corrective actions, maintaining our certifications and ability to do specialty fabrication work.

We continue to expand our fabrication capabilities and have installed and commissioned our plasma cutting pipe machine, increasing the potential output for prefabricated piping. The shop also has some machining capacity now with a mill and lathe for special projects and we're looking to grow that organically as project needs come up.

A couple personnel items to highlight. Tanner Cloud was awarded Shop Employee of the Year for his outstanding work in the shop and helping in the field. We hired on our two summer interns from Butte College for full time roles in Engineering: welcome Adam Squires and Mia Moya to the team!

QUALITY CONTROL UPDATE

Albert Einstein once said, "The measure of intelligence is the ability to change." By this measure, Nova's QC Department is continuing to change and gain smarts. Becca Riley has transitioned to Bremerton Shipyard from Fresno AFB to take over the QCM roles on the Dry Dock 6 and Pumpwell 2 projects from Kirk Allen. Kirk is transitioning to an Electrical Project Manager role supporting all projects at a corporate level. Rey Pelagio has changed to QCM at RAAF Base Tindel while Greg Larson has picked up the lead QCM role at RAAF Darwin, which is changing to start up early in 2023. While the projects are 300 miles apart, Rey and Greg communicate frequently to support each other in this change. Will Wells has transitioned to Project Manager at Aguadilla while still carrying QCM duties as a replacement is being sought. Jim Hubbeling and Burt Cardell have worked with NAVFAC on Dry Dock 4 to complete turnover of the pier's east side, overcoming paperwork and contractual issues. Bruce Levan and Quinn Cartwright are into their second South Dakota winter as the project is preparing for startup early next year. Scott McKee continues to overcome the day-to-day challenges at the Beale AFB project. One new newcomer and one experienced newcomer have joined the Nova QCM ranks. Nick Nguyen started in July by supporting Fresno and Beale projects as well as working with James Dugger to lead the new Environmental committee. Nick is also preparing for the QCM role at the recently awarded LLNS HEAF project to mobilize in January. Kurt Kuha, with a long-storied history at Nova has re-joined Nova as QCM for the Mitchell project, which is set to begin mobilization in March 2023. Charles Jones is involved with the new pipe fabrication machine in the Napa shop and its quality features as well as gearing up for the LLNS HEAF project's higher level QL-2 shop fabrication requirements. 

Wow! Our first Newsletter Update! Hello from the Environmental Team. With the ongoing challenge to remain environmentally compliant, the Environmental Team was developed to ensure the success of Nova Projects worldwide through education, assistance, and compliance in accordance with International, Federal, and Local environmental laws and regulations. We originally were formed in response to the ever-changing stormwater regulations in California. Now we are tackling environmental compliance over multiple states and US territories.

With both state and federal regulations changing, the Environmental Team is focused on getting Nova ahead of the curve. This includes educating our field team about environmental controls, certifying Nova folks as environmental compliance inspectors, and updating our project teams about permitting deadlines and requirements before it's too late. The EPA recently updated their stormwater requirements, so we've been working with our Puerto Rico team. Also, the new EPA stormwater requirements grew stricter than most states. The Environmental Team is anticipating every state to tighten up on their environmental regulations within the next five years, so be prepared to hear more from us as we get Nova more comfortable with environmental.


CISE CURT AWARD

Nova Headquarters hosted two youth group site visits in 2022. The Rosie the Riveter group visited in July. This was a group of young girls interested in the trades and learning more about nontraditional careers for women. The second group visited in December; they were with a Contra Costa youth program. They weren't quite sure what they wanted to do in the future, so visiting Nova introduced them to the opportunities of the construction world. Both groups were able to have hands-on experience with welding and running the excavator or operating the overhead crane.

At the beginning of the visits, a couple of the youth from their group were interested in construction. At the end of the visit, there was a lot more interest and even some excitement.

Public schools don't offer Auto Shop, wood shop or other hands on classes anymore. These visits are a great way to show the youth they can obtain a sustainable career in construction and open their eyes to options that don't require college, which may not be an option for them. We plan to host more youth site visits in the future.
